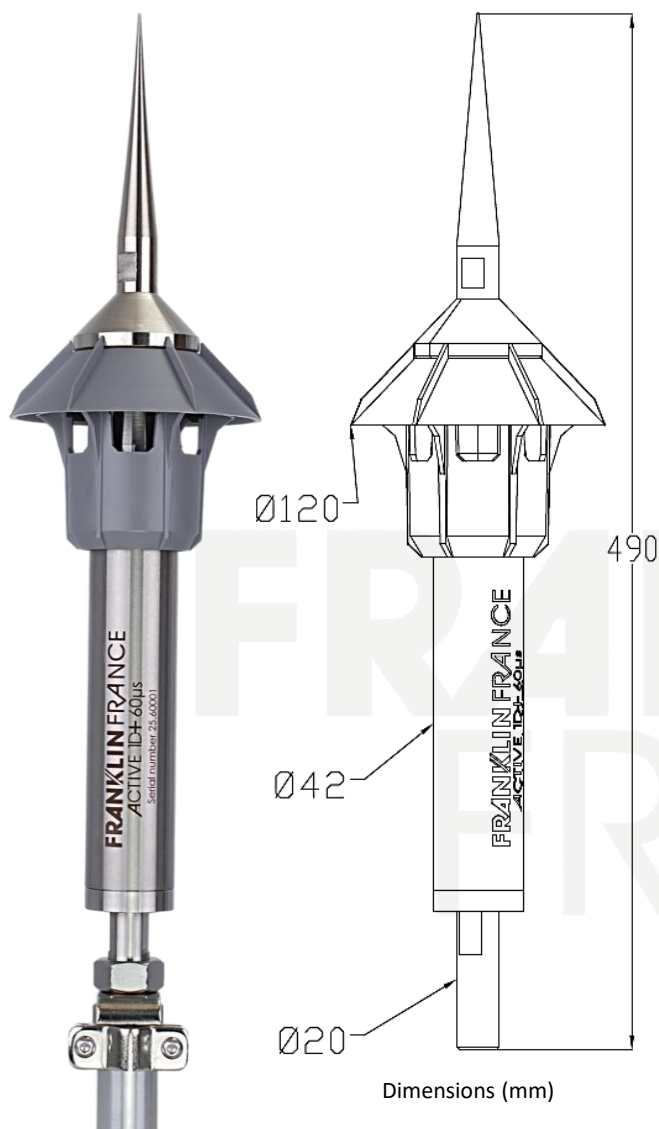




Early Streamer Emission - ESE

Functional principle

The Active 1D+ is an Early Streamer Emission (ESE) with a priming device whose operation is based on an oscillating high-voltage pulse circuit synchronized to the storm phenomenon. The resulting strong amplification of the electric field at the top of the lightning rod tip results in the anticipated emission of an upward tracer at the right moment.
